WARRANTIES

Extended Warranty Terms

Limited Warranty

Your recycled part from Everett's Auto Parts is covered by this limited warranty unless specifically excluded in writing at this time of sale.

General

This warranty applies only to the original purchaser of the part and/or labor warranty and is non transferrable. It is valid only as long as the part is still installed in the vehicle for which it was originally purchased for the period of ___ months or for longer if an extended warranty is purchased. The warranty is not transferable. If any defect is discovered during the warranty period, the Everett's Auto Parts must be informed immediately. All claims must be accompanied by the part and original sales receipt. Defects and all subsequent work must be verified and authorized by the Everett's Auto Parts. Transportation costs of any part or vehicle to Everett's Auto Parts is specifically excluded from the warranty. Everett's Auto Parts reserves the rights to repair or replace any part, or to refund the purchase price of any part at its discretion. Such repair, replacement or refund will satisfy all obligations under this warranty. Any improper use, abuse (including but not limited to: overheating, or low oil or fluids in engines or transmissions), neglect, careless handling, damage occurring during improper installation or repairs, or removal of a part from the vehicle in which it was originally installed after the purchase from Everett's Auto parts shall void this warranty. Melting of heat tabs installed (if applicable) by Everett's Auto Parts will be considered evidence of overheating. Labor costs, including the cost of moving attached external parts from the purchaser's original part to the Everett's Auto Parts recycled part are specifically excluded from this warranty. Seals, gaskets, fluids and similar supplies are also specifically excluded from this warranty. Warranty shall be void if part is used on a commercial vehicle.

Engines

Everett's Auto Parts warrants to the original purchaser the internal parts of its engines to be free of defects for a period of ___ months from the date of purchase. The parts covered by its warranty are the engine block, cylinder head(s) with valves, cam shaft connection rods and bearings, pistons, piston rings, crank shaft and bearings, rocker arms, valve lifters and other internal parts. Excluded from this warranty are the carburetor, throttle bodies, fuel pump, water pump, all electrical parts, hoses, lines, intake and exhaust manifold(s), fuel injector pumps, all other fuel injector parts and all other external parts including distributor. Calibration and adjustment of excluded parts is also excluded from this warranty. This warranty is void if new oil and oil filter are not used in installation.

Transmissions

Everett's Auto Parts warrants to original purchaser its transmission to be free of defects for a period of ___ months from the date of purchase. The parts covered by this warranty are the transmission case and all internal parts including the torque converter. Excluded from this warranty are the transmission mounts, shifting, linkage and flywheel. All other external parts and/or problems that result from not installing new front and rear main seals during installation of the transmission are excluded from this warranty.

Other Parts

Everett's Auto Parts warrants to the original purchaser that recycled parts sold by it will be free of effects for a period of ___ months from the date of purchase. Properly installed and refinished sheet metal parts are guaranteed, for an amount up to their original price, against rust and corrosion for one year from the date of purchase.

Our policy is as follows:

Warranty is valid from date of purchase.

Your labor warranty covers up to \$75.00 per hour in labor cost if a part you purchase from us is defective during the agreed period.

The amount of labor to be compensated for shall be dictated by the Chilton Manual.

A certified mechanic carrying the label ASE CERTIFIED must perform the labor.

Everett's Auto Parts reserves the right to inspect all parts before issuing a check.

WARRANTIES VOID IF:

Seals (including rear main)/Filters/gaskets not replaced, oil pumps not replaced, and/or timing chain/belt not replaced.

Everetts reserves the right to inspect/diagnose the part in the vehicle. Removing the part before we can inspect it voids the warranty.

Warranty does not cover external electrical parts on engines or transmissions including speed sensors, solenoids and throttle bodies.

You must have the original receipt from the Repair Company showing they replaced the part and the original sales receipt for the part.

All parts have an identification stamp.

All parts have a heat tab installed (if applicable). If overheated, the center will melt and all warranties will be void.

Mileage is based on a 12,000 miles per year standard.

3,000k mile oil change must be certified.

All fluids, filters, seals and gaskets are the responsibility of you the purchaser.

If the labor cost is less than seventy five dollars, you will receive only what the labor cost is.

This warranty only covers replacement cost of labor on a complete part.

This warranty guarantees a cylinder head cast against cracks and warpage.

This warranty does not guarantee cams, valves, guides, seats or other such parts.

If you have other MECHANICAL or ELECTRICAL problems with your vehicle, they are not covered by the labor warranty.

The warranty covers only the original purchaser for labor and is non-transferable.

Warranties are not refundable.

Warranties are good for single use.

Additional labor can be purchased after a payout.

Warranty transfer - no allowed PART & labor (labor already written in).

Towing not covered.

All matters regarding the policy shall be settled by Everett's Auto Parts exclusively.

We do not cover any accessories that may have been left on the part for labor replacement cost.
